HORSE RACING

Ante-post prices are offered on most major horse racing events up to the overnight declaration stage (usually 10.30 am UK time on the day before the race). Ante-post bets are accepted on the basis of all in run or not, unless a "with a run" price is offered. Stakes are lost if an ante-post selection does not take part. No Tatterails Rule 4 deductions are made to winning ante-post bets. Where weather or outside influences cause an event to be postsponed or rescheduled to another day then ante-post bets will stand, provided that the entries are not re-opened. Ante-post bets on horse racing will be void if the race is officially abandoned or declared void, or the conditions of the race/evenue is altered. Best Odds Guaranteed has a maximum bonus of £1000 for singles and £500 for Multiples with Max Stake of £500 More. £2650 Mor £500 Win or £250 EW.

Each-way betting - The following place terms apply on each-way bets unless specifically stated at the time of placing the bet: a) Handicaps with 16 or more runners: X the odds for the first four places. b) Handicaps with 12-15 runners: Kit he odds for the first three places. c) All Races with 5 to 7 runners: X the odds for the first two places. d) All non handicap races with 8 or more runners: 1/5 odds 1:-23-e) All races with 2-4 runners - all places money goes on tow in: Each-way bets are not permitted on unnamed favourites, and if accepted in error, will be declared void.
